Job Description / Responsibilities / Requirements

Toshiba Global Commerce Solutions is currently looking for a Logistics Specialist to join our team in Research Triangle Park, NC. A Logistics Specialist is an operations practitioner who will support Toshiba's Worldwide Operations Organization (Logistics Procurement, Operations, Planning, and Global Trade Compliance), in particular, management and maintenance of user data within Oracle Trade Management. The role will be required to support Oracle module maintenance and enhancements by providing user expert knowledge on business process, along with responsibility for master data quality, and business control oversight.

This role will analyse, coordinate and identify improvement opportunities within the company supply chain to ensure compliant data and processes for the physical and systematic movement of product from supplier to manufacturing to customer across international borders. Their expertise lies in subject matter expertise in Oracle Global Trade Management (GTM), Transportation Management (TM), Order Management (OM) and operations business controls, maintaining data warehousing /governance throughout the end-to-end supply chain. The specialist will also be familiar with international regulations for importing and exporting across country borders.

Responsibilities:

- Responsible for ensuring processes and systems comply with company US Export Regulations and are founded on Toshiba Corporate and TGCS' principles of operation and reporting requirements
- Serve as subject matter expert (SME) for Oracle GTM, TM, OM modules
- Perform daily Compliance controls reports, highlighting "business monitor" errors, restricted party list (RPL) and data points of concern (debarred parties, military / catch all flags)
- Create and maintain effective partnerships across organizational functions, regions and management levels, such as finance, accounting (cost accounting, accounts receivable, accounts payable, revenue accounting, treasury), global trade compliance, procurement, suppliers, executive management to achieve the goals of the compliance role
- Support continuous improvement in processes and systems, often facilitating project implementation
- Support development of IT project specification documentation liaise with IT specific to gain alignment/buy-in on budget/resource/timeline and business case topics.
- GTM administration to upload and maintain ship lane transit times, logistics model scenarios (related to direct and indirect sales channel set up). Requires expert knowledge of how Oracle EBS and GTM work its impacts on operations.
- Partners with country level teams on any requirements for changes to shipping documentation and is prime interface with logistics integrator to coordinate the changes. Changes include country level and global HTS/ECCN codes/classifications, EDI/API connection / communication to and from carriers.
- Shipment / freight cost modeling for complex programs, sales business case support and impact to TGCS from national regulatory changes.
- Logistics IT (Oracle modules, carrier API/EDI) projects, coordination for updates.
- Perform other related duties as assigned
