The Temporary DSS will work with leaders to build a school culture where learning standards, data, high quality curricula, and teacher development are used to achieve breakthrough learning for students. The Temporary DSS will be responsible for coaching and developing leadership in a portfolio of up to 12 schools focused on meeting partner needs and supporting the team's leave coverage. The Temporary DSS will work alongside other peer coaches serving schools across the country and collaborate regularly with ANet national teams.
