General Position Summary: Primary focus of this position is to facilitate global trade and help ensure compliance with customs regimes and various other agency regulations, globally. The Trade Compliance Analyst must exhibit strong research and analytical skills, often being asked to interpret import and export regulations and conclude how they apply to Disney, making changes to internal procedures accordingly. Must also review current processes and procedures while thinking critically for process improvement opportunities.

The candidate will accomplish this by tactically and strategically engaging internal and external partners in the process.

### Essential Functions/Responsibilities:

- Represent Trade Compliance by maintaining consultative communication with management and staff across multiple business functions.
- Perform daily operational tasks with supervision and/or collaboration.
- Utilizing expertise in trade compliance operations for import and export transactions
- Performing compliance review of import, export and FTZ documentation for international shipments of tangible items.
- Executing complex transactions and projects, including valuation, assist management, planning, provision schedules, and routing guidance for import/export.
- Validating Country of Origin and valuation details for exports and imports
- Preparing and filing OGA's related to import and export documentation necessary for compliant import and export transactions
- Responding to inquiries and assisting freight forwarder and customs brokers regarding documentation requirements and other import and export regulations in ensuring timely clearance
- Maintaining relationships with freight forwarders, customs brokers, foreign consignees/suppliers, and other strategic vendors to control the efficient flow of tangible items to meet requirements.
- Generating performance metrics for export and import processes
- Participating in various process improvement projects as required
- Monitoring regulatory and legislative changes. When changes occur, communicating updates for internal processes accordingly
- Managing customs recordkeeping in compliance with CBP regulations and Foreign Trade Regulations
- Supporting other Compliance Department activities as assigned.
