In this role you will be responsible for ensuring and operating all aspects of compliance with US and Canada Import/Export Customs Regulations, building new capabilities, maintaining, and executing internal controls (in processes, operations, and systems) to mitigate risks, increasing efficiency, and facilitating Biogen's international trade as well as business growth, collaborating with multiple functions across the organization.

This role reports to Biogen's Americas, Middle East & Africa Trade Compliance Lead and it is based in the US.

What You'll Do

- Manage day to day import/export operations for Commercial and Clinical shipments (through Oracle's Global Trade Management system and other tools), obtain relevant import/export licenses with other government agencies such as FDA, USDA, CDC, Census, BIS, EPA, Fish & Wildlife, etc.,
- Execution of annual reconciliation program with US Customs, liaison and oversight of US and Canada Customs Brokers, Post entry audit, and export reviews,
- Determine US and CA HTS classification and Country of Origin in coordination with Data Governance COE, determine US & CA customs values in coordination with Valuation COE, and US focused Free Trade Agreements qualifications,
- Perform Global Trade Compliance due diligence assessments, and contract governance for product launches to the US & CA and manage status updates in Biogen's Product Life Cycle Management System,
- Work closely with regional and global internal partners (e.g., Distribution and Logistics, Tax, Finance, Quality, etc.) to enable and streamline cross-border activities, and
- Manage different special projects to build Biogen's Global Trade competitive advantage

Additionally, this role is responsible for maintenance, updates, and implementation of US & Canada Trade Compliance standard operating procedures, as well as proactively identifying customs regulatory changes that may impact the business, providing technical expertise and coordinating with stakeholders to adapt internal controls as needed. As well as acting as a Biogen ambassador with leading Trade and Industry organizations in the US and Canada.

- Experience with US Foreign Trade Zones and Customs Bonded Warehouses.
- Direct experience working on complex valuation topics (e.g., Royalties, first sale, valuation methodologies, etc.)
- Experience with multinational setups involving multi-country legal entities and complex supply chains.
- Flexibility working across time zones, and with a diverse global team.
- Excellent communication skills, ability to present across different audiences, organizational levels in business terms complex trade compliance subjects.
