- Responsibility for hiring and training any new staff.
- Resource person for SAP system configuration and tax tables maintenance/modifications.
- Budgets - Prepare budgets and forecasts for all indirect tax issues. Reconcile accounts and explain variances.
- Oversee the customs function of the various departments at Valero Canada to ensure the proper reporting of all imports and exports to Canada Border Services Agency
- Allocate the responsibilities for compliance and reporting as needed in order to ensure the proper party is performing the necessary compliance.
- Minimize customs duties and ensure the duties are timely reported and paid.
- Oversee any audits of our customs compliance and minimize any potential assessments
