Job Summary

The Supply Chain department is tasked with creating value for Makita and its customers by planning inventory to efficiently meet customer's needs, while effectively using Makita's resources. This role manages trade compliance of Import shipments, provides documentation oversight, and supports exports within the Makita's Supply Chain department.

Essential Job Duties

To perform this job successfully, an individual must be able to perform each essential duty to satisfactory standards. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions. Facilitates the flow of products in the international supply chain.

- Imports:
 - Monitor Import shipments from origin, shipper, truckers, steamship lines and airlines to delivery.
 - Verify and maintain Import Documentation; Ensures that all import / export documentation and procedures are followed and comply with all record keeping requirements.
 - Primary liaison between Customs Brokers and Makita Supply Chain team
 - Provide timely backup to Customs Clearance Brokerage teams as needed.
 - Proactive daily cargo monitoring container delivery by Last Free Day [LFD] to avoid demurrage and other accessorial charges.
 - Support daily operational matters by providing oversight and resolution of trade compliance issues which impact the clearance or movement of goods
 - HTS Classification of new parts and tools based on material and function
 - Research, determine and notate other government agency requirements applicable to parts and tools
 - Conduct AD/CVD Antidumping and Countervailing Duty analysis documenting findings
 - File Importer Security Filing (ISF) or 10+2
 - Access and distribute monthly ISF performance reports
 - Research any late ISF's, and implement continuous improvement plan
 - Back-up Freight billing logging and auditing
 - Port Fee's:
 - Manage San Pedro Ocean Port Fee's payments via Port Check Portal
 - Support Oakland Port Gate Fees as needed
 - Produce weekly GL Code reports for Port Fee Payments
 - Prepare reports to assist in Trade Compliance and risk analysis.
 - Apply working knowledge of trade compliance regulations and requirements to support business needs
 - Investigate and resolve data quality problems
 - Maintain compliance due diligence reports, records, policies, and procedures
- Exports:
 - Back-up Export documentation preparation.
 - Monitor Export shipments.
 - Utilize Consolidated Screening List (CSL) tools, report potential matches to Trade Compliance Manager.
 - HTS (Harmonized Tariff Schedule) and Schedule B Classification.
 - File Electronic Export Information (EEI) via ACE Portal.
 - Audit Export documentation, report results.
 - Work with cross-functional Supply Chain team, communication with colleagues ensuring smooth Export shipments.
 - Support Export Compliance and Operational Procedures Manuals.



Other Duties

- Communication and expediting with global companies & vendor orders.
- Review ocean import documents for accuracy (Invoices, Packing Lists, Original Bill of Ladings and ISF).
- Stays current on import / export regulations and other applicable governmental initiatives that affect the business.
- Assist with Trade Compliance audits.
- Other tasks as assigned by the Trade Compliance Manager, or Director of Supply Chain.

Skills Required

- Detail oriented, organized, and able to manage competing priorities.
- Understanding of HTS (Harmonized Tariff Schedule) and Schedule B codes, as well as import and export processes.
- Strong communication skills to work across departments, and with global partners.
- Experience with ERP systems (entering orders, reviewing inventory information, etc.).
- Understanding of tools used to work in a collaborative and hybrid work environment (Microsoft Teams, Planner, Zoom, etc.).
- Knowledgeable of Microsoft Office, primarily Excel, including use of pivot tables, lookups, and other formulas.
- Sense of ownership and pride in your performance and its impact on company's success.
- Maintain Trade Compliance due diligence reports, records, policies, and procedures

Education and/or Experience Desired

The requirements listed below are representative of the knowledge, skill, and/or ability required:

- Minimum 5 years' experience in related fields.
- Degree from accredited university preferred.
- Knowledge and experience with ocean & air import/export, custom brokers, trucking, and all related documentation and terminology.
- Incoterms experience
- In depth knowledge and practical experience working with export and import regulations; Export Administration Regulations (EAR), US Customs and Border Protection (CBP), and Partner Government Agencies (PGA's).

Supervisory Responsibility

This position does not have direct supervisory responsibilities.

Work Environment

This position works in a hybrid environment and will be required to use software and tools to communicate with others while working remotely. At times this role will be needed at the office to receive or arrange export shipments. The work is fast paced, focused on continuous improvement and continuous learning while operating under high demand/volume. This role routinely uses standard office equipment such as computers, phones, photocopiers, etc.

Occasional travel to Makita distribution centers.
