This role will focus on providing industry knowledge on the topics of Export Control Classification Number (ECCN), Harmonized Tariff Schedule Codes (HTS), Country of Origin Determination Rules, as well as Free Trade Agreement knowledge (USMCA in particular) to support exports of Telecommunication and electronic parts and equipment. This role will support CommScope business within the North American region as a part of the Global Trade Compliance Group reporting to the Legal Department. The team supports various trade compliance Export activities for North America.

How You Will Make An Impact:

- Assign Export Control Classification Number (ECCN) and Harmonized Tariff codes (HTS) to components, parts and finished goods using the Commerce Control List (CCL), the USHTS GRI's, rulings, and product specifications.
- Assess and determine Country of Origin using Non-preferential Rules of Origin (RoO) or to qualify products for preferential treatment under Free Trade Agreements (USMCA in particular)
- Ensure compliance with regulations by providing daily support to customer service, sales, purchasing, manufacturing, and product line management teams.
- Develop and/or maintain desk level procedures for your position/function within the Trade Compliance organization.
- Maintain current knowledge of international Export compliance regulations through official publications and both formal and informal training.
- Continuously evaluate Export activities to develop and implement better compliance practices.
- Provide coverage and assistance to other team members as needed in relation to: audits, recordkeeping, classification, etc.
