## **Job Description**

This position supports the Research Security and Compliance program throughout the University of Missouri System. Reporting to and partnering with the Director of Research Security and Compliance, this position leads the development, implementation, and monitoring of the University's export controls and sanctions compliance program. By performing more escalated export control and sanctions reviews, drafting, and managing export licenses, and investigating more complex scenarios, this position supports all universities within the University of Missouri System.

This position is being considered for remote work and would require regular travel to the University of Missouri - Columbia, as well as potential travel to other UM System campuses located in St. Louis, Kansas City, and Rolla, Missouri.

### **Key responsibilities include:**

Serves as the primary point of contact for the University of Missouri - Columbia handling day-to-day export control issues flagged for review. These include, but are not limited to, contract reviews, I-129 Attestation requests, visiting scholar reviews, international travel reviews, and international shipping requests.

Implements and monitors Technology Control Plans (TCPs) to ensure compliance with export control regulations and related contractual obligations.

Works closely with compliance professionals at UMKC, MST, and UMSL to performs export control reviews from their institutions when flagged for higher-level review.

Works with key constituents within the UM System to develop procedures, educational materials, and best practices to strengthen the export controls and sanctions programs within the UM System.

Maintains expertise related to ITAR, EAR, and OFAC regulations, NSDD-189, CUI policies, and participates in professional development opportunities

Supports UM System policies and procedures regarding ethical behavior, safety, security, use of university property, etc.
