- Develop and implement a best-in-industry export compliance program, including policies and procedures, training, risk assessment, technology, and systems
- Develop and support comprehensive risk-based export controls and audit procedures to ensure compliance with US regulations including the Export Administration (EAR) Regulations, the International Traffic in Arms (ITAR) Regulations, and the Office of Foreign Asset Control (OFAC) regulations and sanctions programs
- Advise and guide business units that export goods and technology
- Conduct export analysis and facilitate obtaining export licenses and permits
- Participate in selection and management of foreign customs brokers
- Investigate and resolve export compliance violations
- Work with Legal department attorney responsible for providing legal advice regarding export compliance

Minimum Qualifications

- Bachelor's Degree or equivalent experience
- Five+ years of experience with U.S.-based customs and trade compliance laws and regulations
- Hands-on experience developing or maintaining an export trade compliance program within at a multinational company
- Expert understanding of and experience with US export controls, sanctions, and practices
- Knowledge of logistics
- Experience conducting export analysis with an understanding of export licensing
- Must be a "U.S. Person" as defined by ITAR and EAR

- Licensed Customs Broker
- Experience in aviation, engineering, or aircraft maintenance
