- Serve as contact for Customs brokers to insure the proper declaration of information and provide discrepancy resolution to ensure timely processing of entries
- Support the development, maintenance, and delivery of internal training programs as necessary
- Assist in the review, development, and implementation of Customs Compliance procedures while complying with all federal regulations
  - Maintain Customs Compliance databases as necessary
  - Maintain records in accordance to Customs and Thermo Fisher's record retention policies

- Develop corrective action recommendations for non-compliance of any policies, laws, regulations, or contract requirements
- Process internal post-entry amendments to ensure compliance with Customs regulations
- Identify opportunities for duty refunds and savings including classification, valuation, trade programs, and duty drawback
- Generate compliance metrics for reporting within the department and to management
- Perform other compliance related duties and/or projects as required, including, but not limited, to: supply chain security, export reviews and licensing, and performing audits
- Other duties as assigned
