Major Tasks and Responsibilities:

• Properly file import and export records

- Audit to ensure accurate and timely export filings are completed in ACE Customs system
- Prior to export ensure US export control regulations and licensing requirements are met
- Coordinate daily import/export compliance tasks
- Coordinate with Customs brokers and forwarders to ensure accuracy of import/export documentation
- Responsible for ensuring that all export orders are screened and cleared through Precision compliance
- Determine qualification and create FTA's for International customer orders as needed
- Prepare shipping documents and ensure all required export documents are included for International shipments
- Work with Freight Forwarders to arrange timely shipment of goods to International customers
- Help arrange inbound shipments (quote, pick forwarder, follow up)
- Act as back up international shipping role for Punta Gorda and Rochester facilities, as needed, in absence of other logistics personnel; (cover vacations, sick leave etc).
