This position will report to the Manager, Customs and Global Trade Compliance and supports the maintenance and continuous improvement of Wolfspeed Inc.'s Global Trade Compliance program. Duties will include serving as a subject matter expert on the interpretation of regulatory requirements for import and export activities, HTS classification management, Custom's entry verification, providing regulatory guidance to assist in import/export clearance delays, and other compliance activities within the organization.

The Day-to-Day:

Under general direction with minimal supervision and in accordance with all applicable government laws, regulations, procedures, and guidelines, this position will:

- Work with various functional areas to determine their export/import needs and provide guidance and interpretation of the international trade compliance regulations. Experience with EU, UK and China trade laws are a plus
- Review with business managers their Global Trade Compliance internal controls (procedures, work instructions, policies, forms, checklists, etc.) to ensure they are appropriate strategies to meet business requirements and ensure full compliance with all regulatory agencies
- Provide final approval for Harmonized Tariff Schedule (HTS) and Schedule B classifications while maintaining internal database and sharing with our external Customs Brokers
- Assist in export classifications, country of origin determination, and HTS classifications for new components, finished goods, machines/equipment, and other internal and/or external products



Perform post entry audits on entry packets for accuracy and completeness while maintain proper record keeping according to Customs regulations

- Perform transaction due diligence and perform red flag analysis to evaluate any potential risks
- Support special projects as needed
- Provide global support for trade compliance matters based on local and international regulations
- Ensuring compliance with U.S. Export and Import control laws and regulations and applying for all necessary export/import authorizations when needed
- Customs Broker relationship management and activity assessments
- Evaluating duty savings opportunities including Duty Drawback, Free Trade Agreements, and Foreign Trade Zones
- Provide cross functional support gathering information to determine export licensing needs and utilize license exceptions when applicable

- Ability to exercise independent judgment to complete complex tasks in creative and effective ways
