Export Compliance

- Develops and manages the export compliance program to ensure compliance with the International Traffic in Arms Regulations (ITAR), Export Administration Regulations (EAR), Office of Foreign Assets Control (OFAC) requirements, U.S. Foreign Trade Regulations (FTR), U.S. Customs Regulations and Nuclear Regulatory Commission (NRC) export regulations.
- Obtains ITAR licenses; prepares Technical Assistance Agreements (TAAs) and amendments; manages implementation of TAAs and

<u>Technology Control Plans (TCPs); applies for Bureau of Industry and Security (BIS) licenses; guides labs, programs and departments to obtain appropriate licenses and permits required to support research activities.</u>

- Coordinates and advises logistics and labs/programs on international shipments of export-controlled items.
- Serves as the primary point of contact for all export control matters and ensures the Empowered Official is fully informed and briefed on matters requiring approval and/or certification.
- Works closely with senior leadership and staff to provide guidance and strategic consultation on decisions that have import/export impact.
- Develops, oversees, and monitors organization-wide export control policies, procedures, and tools to promote and facilitate compliance with federal, state, and local laws and regulations.
- Ensures proper record-keeping for documentation of import/export-related files in addition to other documents and files generated as part of the duties of the position.
- Provides regular training to staff in all export control related matters, including mandatory employee training.
- Manages selection, configuration, implementation, and reporting functions of restricted and denied party screening software (including the database of export-controlled items and technical data).

Research Integrity

- Oversees and ensures compliance with the responsible and ethical conduct of research (RECR).
- Assists with management of research conflict of interest (COI)
 program in connection with the Ethics Officer, including financial
 conflicts of interest, personal conflicts of interest and organizational
 conflicts of interest, and outside employment.
- Supports implementation of the institution's COI policy and procedures to include integrating revised COI policy into export and research security policies and processes as relevant and necessary.
- Provides technical assistance and expertise in evaluating and managing RECR, COI and outside employment.
- Provides outreach, education and training on RECR, COI and outside employment and all related regulations, policies and procedures.
- Stays informed and works closely with Contracts to ensure current knowledge regarding changing federal, state and other sponsor requirements.

 Researches, develops and promotes tools for efficiency in managing RECR, COI and outside employment.

Research Security

- Develops, oversees and monitors organization-wide research security controls and processes to promote and facilitate compliance with research security protocols and regulations (federal, state and local) and best practices.
- Develops and facilitates Research Security Working Group to perform ongoing gap analysis with existing policies and processes, develops risk mitigation measures, develops processes to conduct screenings for foreign national visitors, and develops an organization-wide training program on research security regulations and best practices.
- Collaborates with senior leadership to ensure that the research security program is following applicable laws, regulations, and contractual requirements and offers a broad range of outreach services and training, communications and collaborations with labs, programs and departments.
- Establishes annual and long-range research security and compliance goals that align with the Strategic Plan.
- Leads efforts to comply with non-research security specific sponsor or other regulatory requirements through update or creation of new policy, procedure or processes.

Supervisory Responsibilities

- Supervises and manages the export and research security work performed by the Research Compliance Analyst.
- Provides mentoring and training for Research Compliance Analyst.

- Experience in export classification for hardware, software, technology and in working with scientific and engineering staff to determine appropriate classification.
- Experience using DDTC and BIS systems, DECCS, SNAP-R and other automated government portals and systems.
- Experience working within a federal regulatory framework, including reviewing and understanding federal regulations, seeking legal advice and applying regulations in a clear and concise manner.
- Experience in managing Responsible and Ethical Conduct of Research (RECR), Conflicts of Interest (COIs) and outside employment requests.
- Experience in managing research security in a complex and decentralized IT infrastructure and collaborating with cybersecurity professionals.

- Knowledge of privacy, information and data security laws (e.g., HIPAA, GDPR), and NIST risk framework.
- <u>Demonstrated expertise in working with senior leadership and across multiple organizational levels in oversight and coordination of activities involving professionals from different internal organizations.</u>
